

## Privacy Policy

We value the trust you place in us. That's why we insist upon the highest standards for secure transactions and applicant information privacy. Please read the following statement to learn about our information gathering and dissemination practices.

### **1. PAYMENT SECURITY**

We do use your contact information to send you information.

### **3. USE OF DEMOGRAPHIC AND PROFILE DATA**

We use Personal Information for any payment for smooth conduct of Transaction. And check your payment from time to time.
